2.1	Costs	<p>Costs – Points will be allocated on the evaluation of pricing for each sub-total item on the pricing tables in the following format:</p> <p>USD Prices will be converted to CAD as at the USD-CAD noon rate specified by the Bank of Canada (http://bankofcanada.ca/en/index.html) on March 15th, 2010. The lower sub-total price, will then be used in determining point allocations, and then aggregated to form a total price score:</p> <p>The lowest compliant bid will received 60 points, with the remaining compliant bidders receiving points based on the following formula: Lowest bid divided by their bid multiplied by 60. See example:</p> <p>Assuming two compliant bids, one bid totaling USD\$100,000 and another at USD\$150,000. The lowest compliant bid of USD\$100,000 would received 80 points. The second bid would receive:</p> <p>$\\$100,000/\\$150,000 \times 60$ points $= 0.67 \times 60$ points $= 40.2$ points</p>	<p>Rated Requirement: /60</p>
