

Canadian Commercial Corporation
Annual Report to Parliament on the *Privacy Act*
April 1, 2015 – March 31, 2016

1. Introduction

The purpose of the *Privacy Act* is to extend to individuals the right of access to information about themselves held by the government, subject to specific and limited exceptions. This *Act* also protects individuals' privacy by preventing others from having access to their personal information and gives individuals substantial control over its collection, use and disclosure. The *Privacy Act* took effect on July 1, 1983.

Section 72 of the *Privacy Act* requires that the head of every government institution prepare for submission to Parliament an annual report on the administration of the *Act* within the institution during each financial year.

The Canadian Commercial Corporation (CCC), a Crown corporation of the Government of Canada, listed in Schedule III Part I of the Financial Administration Act, reports to Parliament through the Minister of International Trade. CCC has a mandate to facilitate international trade and acts as Canada's international contracting and procurement agency.

CCC connects foreign government buyers with Canadian expertise through the negotiation and execution of government-to-government contracts. The Corporation's strong relationships with international buyers and our access to Canada's innovative industrial base put us in a unique position to facilitate and promote international trade.

The Corporation focuses on areas where there is a clear role for government, operating in sectors outside of World Trade Organization agreements, such as aerospace and defence. We also focus on emerging and developing markets, where governments of other countries may require additional capacity to undertake complex and timely procurements and projects. CCC can operate either as Prime Contractor selling to governments, or as a Procurement Agent sourcing Canadian goods and services on behalf of governments in other countries. The Corporation also procures equipment, supplies and expertise to help the Government of Canada fulfill its in-kind aid contributions worldwide.

2. Structure

The administration of the *Privacy Act* which, due to the size of the Corporation (approximately 140 employees), is a function assumed by Legal Services. The Vice-President, Legal Services, General Counsel & Corporate Secretary is a member of the Corporation's executive committee and is the Access to Information and Privacy Coordinator. The position is supported within Legal Services by a junior Legal Counsel, a new Law Clerk position dedicated to the processing of ATIP requests and available administrative resources.

The Coordinator ensures compliance by the Corporation by processing requests for personal information in accordance with the legislative obligations, relevant regulations, directives and guidelines of the *Act*.

3. Delegation Order

For the purposes of section 3 of the Privacy Act, the President of CCC is designated as the “Head” of the institution.

Pursuant to section 73 of the Act, the President’s authority has been delegated to enable the Corporation to meet its legislated requirements. The President has delegated his powers and duties to the Vice-President Legal Services, General Counsel and Corporate Secretary, who is also the ATIP Coordinator.

A copy of the Delegation Order, dated April 20, 2015, is attached as Annex A.

4. Statistical Report

The number of requests the Corporation has received over the past several years has been consistently low. In fiscal year 2014-2015, CCC received one request under the Act, which was subsequently withdrawn by the requestor. In fiscal year 2015-2016 there were no requests received under the Privacy Act.

There were no costs associated with the administration of the *Privacy Act* during the reporting period.

The statistical report is attached as Annex B and has been submitted to the Treasury Board of Canada as required.

5. Education and Training

The Canadian Commercial Corporation did not conduct any internal training in the reported fiscal year due to lack of staff relative to the operational demands of the Corporation, as well as the consistently low number of requests received historically.

6. Policy, Guidelines and Procedures

Our institution did not implement any new and/or revised Privacy Act policies, guidelines or procedures during the reporting period.

7. Complaints and Investigations

During the reporting period, the Canadian Commercial Corporation did not receive notification of any complaints and/or investigations.

8. Time Monitoring to Process Requests

As no Privacy Act requests were received in the report period, CCC did not monitor time involved in processing Privacy Act requests.

9. Privacy Breaches

No privacy breaches occurred during the report period.

10. PIA (Privacy Impact Assessment)

The Canadian Commercial Corporation did not complete any PIAs during the reporting period.

11. Disclosure of Personal Information pursuant to paragraph 8(2)(m).

During the reporting period, the Canadian Commercial Corporation did not disclose any personal information pursuant to subsections 8(2)(m) of the *Privacy Act*.



Delegation Order


