

U.S. DoD Prime Contractor Program

Our U.S. DoD Prime Contractor is a free program offered by the Government of Canada, supported by the U.S. Government, and administered by CCC that is designed to simplify the process for Canadian businesses to sell their products and solutions to the U.S. Department of Defence (DoD). We provide advice on how to bid on an opportunity, vet and endorse your proposal, and troubleshoot issues through the life of your contract with the U.S. DoD.

Using this program is mandatory for any contracts over USD\$250,000 between Canadian businesses and any branch in the U.S. military.

Interpretation of bid documents

We answer your questions about U.S DoD solicitations and help you interpret their documents.

Price review

We certify that your price is fair and reasonable, which eliminates the need for you to present cost and pricing data that conforms with U.S. accounting standards.

Endorsement and advocacy

We review your proposals, perform due diligence reviews and provide a Government of Canada guarantee of contract performance. We also support you with any disputes or export challenges.
