How CCC builds successful G2G contracts

Project definition and information gathering

Government buyer identifies a need and works with CCC to sign an MOU and define success criteria.

Proposal development

CCC enters into a pursuit agreement with Canadian business to develop an unsolicited proposal for the government buyer.

CCC manages all contractual issues and financial administration.

that are looking to scale up or transform the delivery of public services and require expertise and technology unavailable in their domestic supply base.
